Maintaining the child care registry and CCRR membership; responding to requests for child care referrals and subsidy assistance to parents, care providers, community service providers and the general public. Providing outreach services, as directed by the Coordinator, to families, Licenced, License-Not-Required and informal care providers. Organizing and maintaining the Early Learning / Toy Lending Library including cleaning and moving equipment, managing the computerized membership, loan and return records. Assisting the CCRR Coordinator to organize and present professional development workshops, training, and networking events as well as program promotion, participation in community events, relevant meetings and advisory committees. Works collaboratively with families, community professionals, provincial and regional child care planning bodies and funders in the promotion of quality child care.
